SOLVENT-BASED ANTI-WRITING PROTECTION FOR GLOSSY, SMOOTH, BRUSHED SURFACES



DESCRIPTION

CIBERGRAF L is a solvent-based product suitable for protection from writing and soiling caused by spray paints and markers of glossy and smooth surfaces, made of stone material. The product forms an invisible barrier to prevent the absorption of such souling agents, significantly limiting their penetration into the support.

CIBERGRAF L allows to intervene for the removal of such stains using cleaning products and equipment for common use. It is also possible to use only pressurized water (minimum 150 amp) or thin steel wool scourer, if the intervention concerns small surface areas to be cleaned, or simply with SOLV X slow evaporating solvent using a slightly abrasive pad.

YIELD

The yield varies from 10 to 20 m² of surface with 1 L of product.

- · Very absorbent surfaces: 10-15 m²/L
- \cdot Low absorbent surfaces: 15-20 m²/L

APPLICATION

The product can be applied manually, by brush or with a cloth, on clean and dry surfaces, in a uniform way. In the case of highly absorbent surfaces, a second hand after 6/12 hours from the first can be applied; in the presence of excesses of treatment, their removal will be possible by rubbing with a felt. Do not apply with temperatures below $10\,^{\circ}$ C, the product is ready to use.

ALWAYS CARRY OUT TESTS BEFORE USE

Anyone, before use, needs to know the characteristics of our products by reading the label affixed to each package, the technical data sheet and the safety data sheet compliant with Regulation (EC) 1272/2008 (CLP) (and subsequent amendments and adjustments) and of Regulation (EU) 2015/830, or eventually by contacting us directly. If solvents are used to remove writings, provide the application of an additional coat of product in order to regenerate the treatment on the surface. The product cannot stand freezing, store it in well-closed and well-protected places, at a temperature not lower than 10 °C.
