YIELD

The yield varies from 4 to 30 m² of surface with 1 L of product. Below we indicate some finishes and their respective yields:

- Sandblasted / Bush-hammered / Flamed: 4-6 m²/L
- Matt polished: 7-15 m²/L
- Glossy: 30 m²/L

DESCRIPTION

CS 51 WET is an anti-stain product with a wet effect, based on water, suitable for the protection of stone and terracotta surfaces. The presence in the formulation of small amounts of solvents compatible with water makes it suitable for application on supports that still have traces of moisture inside them, without that this renders the application ineffective.

The formulation of CS 51 WET is the result of years of experience in the treatment of stone surfaces that allowed us to obtain an ideal product for professional use since, in addition to maintaining the characteristics protection of solvent-based products this product, for its compatibility with water, allows to significantly reduce the times of intervention and the relative costs, just think of the dead times caused by waiting for the surfaces to dry after washing, before treatment.

Despite its characteristics of total compatibility with water, it is recommended not to apply it on supports excessively wet, which while not nullifying the effectiveness of the treatment, would make it less valid over the time. If an overlap with products is required, finishing based on waxes or water-based resin, will not occur problems of any kind. The product can be applied on marble, granite, beole, sandstone, volcanic stones, agglomerated of cement and grit, standard and rustic/artisan terracotta, basalts, which can be used to obtain flooring rather than coverings, facades, ventilated walls, etc.

APPLICATION

CS 51 WET can be applied with normal treatment methods such as those by brush, spray, roller, cloth, in lines of production, rather than personal methods honed by professionals in their operational experiences that also vary depending on the type support and finish you want to obtain. We indicate below, based on our experience, the types of application to be carried out on a series of finishes:

- MATT POLISHED with cloth
- · SANDBLASTED BUSH HAMMERED by brush or spray
- FLAMED by roller, by spray

RECOMMENDATIONS

Wait at least 12 hours before applying a second coat. The product cannot stand freezing, store it in well-closed and well-protected places, at a temperature not lower than 10 °C. Always protect yourself with mask, gloves and protective clothing.
